## 1 Apologies

## 3 Minutes of meeting held 13 September 2021

The minutes of the meeting were unanimously approved and signed. Councillor Norman advised that the allotment hedges have now been cut. He has paid in cash, the receipt was approved and the clerk will settle the bill. The clerk will remind the tenant of plot 1b that a date is required for giving up the plot.

#### 4 Questions from the public

An update was requested about the bridge on the Riverside land that is in need of repair. Peggs have looked at it and it may need some welding work doing. It was agreed that the clerk will report the overgrown hedge between Aldeview and Low Barn Farm as several complaints have been received from tractor drivers.

# 6 Clerk's Report

The correspondence log was circulated prior to the meeting. Councillor Norman advised the road sign for Mill Lane has been uprooted by an oil tanker. It is unlikely that the county council will fix it as they are only fixing mandatory signs. The clerk advised that SALC are revamping their website and providing clerks with a new portal. Councillor Norman approached the gamekeeper at Glemham Hall following complaints about shot falling on houses. He was advised that the shooters will be spoken to about safe distances.

Councillor Norman will examine the sign to see what refurbishment, if any, needs doing. Otherwise it was agreed that no further action will be taken.

#### 10 Casual vacancy

Councillor Norman has advised he has been contacted by Annabel Warne who has expressed an interest in the vacancy. It was agreed that the clerk will approach Mrs Warne and if she is still interested she will be co-opted to the council at the next meeting and the clerk will arrange an induction session.

### 11 Review of Standing Orders and Financial Regulations

There have been no amendments to either the Standing Orders or the Financial Regulations but they must be reviewed annually. Councillors have reviewed the papers and approved the documents.

#### 12 The Sizewell Project

There is then a six week period to allow for Judicial Review applications.
